

Information on Data Protection Regarding the Call for Contribution Form for the DHBW Research Day 2023

In the following, we would like to inform you about the processing of your data in context of the accomplishment of the DHBW Science Day. Personal data is not transferred to third parties. The data is used exclusively for organising and carrying out the event. 1. Extent of personal data processing

During the registration/submission process via the online form of the DHBW Research Day, the following data is transferred to us and stored. These are:

- *name, academic title, affiliation*
- *DHBW academy/corporation/organisation/university*
- *Faculty/department*
- *Email address*
- *Phone number*

Furthermore, the following data is collected:

- *IP address of the requesting processor*
- *Date and time of the registration*

2. Legal basis for data processing

The legal basis for data processing is Art. 6 subsection 1 letter a GDPR.

3. Purpose of data processing

Data is collected for organising and carrying out the event.

4. Duration of storage

Data is erased as soon as it is no longer needed for the means of the organisation of the event.

5. Right to object and deletion of data

You have the right to

a. *request information on the categories of data being processed, the purposes of processing, any recipients of the data, the planned storage period (Art. 15 DSGVO);*

b. *to demand the correction or completion of incorrect or incomplete data (Art. 16 DSGVO);*

c. *recall a given consent at any time with effect for the future (Art. 7 para. 3 DSGVO);*

d. *revoke a data processing that is to be carried out on the basis of a legitimate interest for reasons arising from your particular situation (Art. 21 (1) DSGVO);*

e. *in certain cases, within the framework of Art. 17 DSGVO, to demand the deletion of data - in particular as far as the data is no longer required for the intended purpose or is processed unlawfully, or you have revoked your consent in accordance with (c) above or declared an objection in accordance with (d) above;*

f. *under certain conditions, to demand the restriction of data, insofar as deletion is not possible or the obligation to delete is disputed (Art. 18 DSGVO);*

g. *to data portability, i.e. you can receive your data that you have provided to us in a common machine-readable format and, if necessary, transfer it to others (Art. 20 DSGVO);*

*h. complain to the responsible supervisory authority about data processing (Landesbeauftragte*r für Datenschutz und Informationsfreiheit Baden-Württemberg).*
